ADMINISTRATIVE CONSENT AGREEMENT


On January 13, 1981, the Board of Registration in Medicine granted a continuance of the hearing, scheduled for that day, on allegations that you unlawfully delegated to your wife certain medical functions, in violation of 32 M.R.S.A. § 327C. The continuance was granted on the basis of your admission of the truth of these allegations, and on the basis of your agreement to immediately and permanently cease this unlawful delegation and to agree to a probationary period of one year, beginning on the date you sign this agreement.

THEREFORE:


- (1) Dr. Ekinici admits that he delegated to his wife, Ursula Ekinici, certain duties constituting the practice of medicine, to wit: examination of patients, diagnosis of ailments, and prescription and administration of medication;
- (2) Dr. Ekinici admits that his wife is not licensed to perform such duties;
- (3) Dr. Ekinici admits that the above delegation was in violation of 32 M.R.S.A. § 3282(5) (H), § 3270 and Board Rule 10-373 Chapter § 6(B) (1) and (2);
- (4) Dr. Ekinici agrees to immediately and permanently cease such unlawful delegation;
- (5) Dr. Ekinici agrees to be placed by the Board of Registration in Medicine on probation for a period not to exceed one year past the date Dr. Ekinici signs this agreement, during which time the Board would monitor his activities in whatever reasonable manner they deem appropriate;
- (6) The Board of Registration in Medicine agrees to temporarily withhold prosecution of this disciplinary action against Dr. Ekinici until the probationary period has ended, and to

permanently withhold prosecution of this disciplinary action against Dr. Ekinici upon successful completion of the probationary period.


